REPORT OF THE SENIOR PASTOR

It is truly a joy and a privilege to write the first of what I hope to be, God-willing, many contributions to the Annual Report of the Presbyterian Church in Morristown. I have felt so warmly embraced by the people of this church and I give thanks each day for your patience, trust, and kindness. It is a blessing to be part of this congregation and I'm so grateful to serve as your Senior Pastor.

When I began here on September 1, I shared four areas of focus for my first few months in this role: Worship, Stewardship, Leadership, and Relationships.

Worship is, of course, the center of our life together and I have enjoyed learning about the (many!) things that make praising God at PCM so special. From the incredible music to the creative liturgical moments steeped in all the richness of the Reformed tradition, worship at PCM is spectacular! Some highlights for me have included my Service of Installation, All Saints Sunday, the Thanksgiving Festival, and the services on Christmas Eve, Christmas Day, and New Year's Day.

Stewardship was a months-long, team effort that has measured its success not only in dollars pledged, but in congregational participation expanded. To that end, we did our best to involve as many people as possible in this year's campaign. While we are still receiving commitments as I write this (three more pledge cards came in last Sunday!), the numbers on both fronts are promising. I'm so encouraged and excited by the support of PCM's generous members and friends.

Leadership - wow - do we have deeply faithful and committed people who serve in a variety of ways! I feel so grateful for the many lay leaders who give their time, talent, and treasure to make the ministries of our church happen. We also have such a gifted and inspiring staff, whose energy and enthusiasm for the work to which they have been called makes coming to the office an absolute joy. God has blessed PCM with incredible, capable leaders who give me great hope that our future will be vibrant and bright.

Relationships are the glue which holds the PCM family together. I have loved getting to know this congregation - during fellowship hour after church, over coffee at LOKL on Wednesday mornings, during Midweek dinners, at meals in your homes, and especially when James and I hosted an open house at the manse to say thank you for the welcome we have received from all of you. Ultimately, it's the people of PCM that make it such a special place and it's been wonderful to get to know you.

Relationships are also the reasons churches grow. When we expand the network of people who are invited to participate in the life of our congregation, we help to grow the body of Christ. The gospel is good news for a troubled, lonely, complicated world... and God wants us to share that good news with others! Not long ago, I realized that in 10 years, PCM will celebrate its 300th birthday. Extending an invitation to friends and

neighbors to join us is the best way to ensure that PCM will be here for hundreds of years more.

For the next few months, my areas of focus will be centered around people-groups within and beyond the church: families with young children, empty nesters, and older adults. We serve these groups well, but I'm wondering how we can build upon our strengths as we seek to deepen engagement for each of these populations. I think the opportunities we have are tremendous and I can't wait to see what God can do among us! Thank you, dear friends, for the honor it is to serve with you in this ministry.

REPORT OF THE ASSOCIATE PASTOR

As I sit here writing to you, I have just hit six months since my first day here at PCM, and six months since I had the honor of having my ordination service here not only in my first week working here, but on my first Sunday with you all! While there are many more highlights noted below, I would like to voice my gratitude to each of you and our fabulous staff for welcoming me so well into our congregation and community and affirming my call to serve as your associate pastor. While we are only six months in together, you have all been so gracious and I will be forever grateful for your generosity, love, and care that you have shared with me in worship, our meetings, tea and coffee dates, programs, and events over the course of my time here so far.

Congregational Care

Pastoral care and building relationships have been one of my primary focuses since I began last July. While I still have many more of you to meet and continue to get to know, meeting and getting to know you all has been my greatest joy at PCM so far, and I am excited to continue to build our relationship together. A few of the areas of focus around congregational care have included:

- Meeting with all of our Elders and Deacons.
- Meeting many of our congregants, especially those with acute pastoral care needs.

- Developing and rebranding our Sunday adult education hour, "Doughnuts and Theology," which now provides weekly programming for adults with a participatory model of education.
- Reinstating our Adult Education Committee.
- Creating Advent and Lenten Devotionals.
- Bringing back our weekly dinners and making space for the whole church family.
- Scheduling regular movie nights for the whole church family.
- Working with our Outreach Committee to continue developing relationships with the community and contributing to our events.

In addition to all of these programs and all of our work together, I am excited to imagine how we can continue to be the creative, hopeful, and joyful church PCM is called to be. As we plan for the coming year, I am excited to see where God takes us as we build new programs, pray together, and learn more about what it means to be God's modern-day disciples in our community.

THE PRESBYTERIAN CHURCH IN MORRISTOWN, NJ ANNUAL MEETING OF THE CONGREGATION AND OF THE CORPORATION FEBRUARY 13, 2022

<u>PART 1</u> Congregational Meeting

I. The Call

In accordance with the requirements of the constitution of the Presbyterian Church, USA, and the bylaws of the Presbyterian Church in Morristown [2E], the congregation was notified on at least two successive Sundays prior to the meeting that "The Session of the Presbyterian Church in Morristown calls the Annual Congregational Meeting for Sunday, February 13, 2022, at 11:00 a.m. in person, for the purpose of receiving the annual committee reports, the presentation of the 2022 Budget, the report of the Audit, the approval of By-law changes, approval of the 2022 Nominating Committee, the dissolving of the Terms of Call of Rev. Sarah C. Green, the Election of Corporate officers, and other business which may rightly come before the Congregation." (G-1.0503)

II. The Meeting was called to order by the Moderator, the Rev. Leslie Dobbs-Allsopp, at 10:58 a.m. and the convening prayer was offered by the Moderator. Conferring with the Clerk of Session, the Moderator declared there was a quorum present. Pastor Leslie instructed the ushers to hand out hard copies of the Annual Report to those in the sanctuary. The moderator announced that the meeting was being livestreamed but only those in person were able to vote. Rev. Dobbs-Allsopp announced that Treasurer, Karen May and Clerk of Session, Wendy Doidge have agreed to serve in their respective roles for 2022. Session voted to approve both Karen and Wendy. We are grateful to have their experience going forward to help when the new pastor is called.

III. Minutes

In accordance with the Book of Order, the Minutes of the Annual Meeting of the Congregation and Corporation held on February 14, 2021, were reviewed, and approved by the Session of the Presbyterian Church in Morristown at its first regularly scheduled meeting following the annual meeting. Copies of those minutes were sent electronically and available to all members for their review. Forty hard copies were mailed to those members for whom it was a better option. No further action was required.

IV. Treasurer's Report

Treasurer Karen May gave an overview of the 2020 audit, 2021 results, and the outlook for 2022. Audit results are available for anyone who wishes to review them by contacting Karen. Our 2021 cash flow was favorable thanks to two very generous bequests and the PPP loan of \$172,000. It certainly helped with the deficit. As of February 2022, the PPP loan was forgiven. We exceeded our 2021 pledges by \$60K. It was noted that building use revenue was starting to come back in 2021 as pandemic restrictions loosened. Most of our committees spent less because of decreased activity because of the pandemic. Insurance costs continue to rise mostly because of the value of our many buildings. A review of our insurance did not yield any appreciable savings. It is projected that 2022 expenses will be higher as we have new hires from Management & Administration and there will be no PPP loan. Pledges thus far this year are lower than anticipated. After a review of our finances, our portfolio consultant, Mariner Wealth Management, suggests a \$400K total yearly withdrawal from our portfolio. A Strategic Committee, made up of members of Buildings & Grounds and Management & Administration, was formed to help get our spending down. (See Appendix 1) for full report.

V. Church Audit - Nisivocca LLP

Elder May reported on the professional audit report from Nisivoccia LLP. It is currently recommended that we have a professional audit every year for consistency purposes in completing the audit. The Finance Committee will review this policy every year. (See Appendix 2)

VI. Presentation of Church Budget for 2022

Elder May noted that the Session approved the 2022 budget at the December 16, 2021, meeting. (A copy of which is in the Dec 2021 minutes)

VII. Presentation of Congregational Reports

Reports were handed out. Pastor Leslie asked the Congregation to let Kay Smith know if any errors were found in the report so that they may be corrected in the archived reports.

VIII. Items for Action:

1. By-laws Change - Section 2D:

All voting at meetings of the Congregation and of the Corporation shall be in person; proxies shall neither be solicited nor recognized. Proposed change: Meetings of the congregation, session, and other teams, commissions, boards, groups, or bodies of the church may be conducted by electronic means, provided that the technology selected allows for simultaneous communication, and that all who would ordinarily participate in the meeting are able to access the technology chosen. Proxies shall neither be solicited nor recognized. Rationale: To update the by-laws to agree with practice. **A MOTION** was made and seconded for the change. There was no further discussion. The congregation **APPROVED** the by-law change.

2. Electronic Meetings/Zoom:

The congregation votes to affirm all actions taken at electronic meetings since the onset of the pandemic in 2020 and have recorded them in the official minutes. Rationale: To ratify the actions taken at online congregational meetings during the pandemic. A **MOTION** was made and seconded for the change. There was no further discussion and the congregation voted to **APPROVE** the action.

3. Elect the 2022 Nominating Committee:

Rev. Dobbs-Allsopp noted that the Clerk of Session sought candidates to serve on the Nominating Committee prior to the annual meeting. Pastor Leslie explained that Elder Dick Kaller is the committee chair and Elder Dianne Grenz is the session representative. Helen Quinn is the Deacon representative and from the congregation at large: John Alessio, Ray Doidge, Jenny Fleischer, and Michele Yampolsky. There were no nominations from the floor. **MOTION** to elect was seconded and **APPROVED**.

4. Dissolution of the Terms of Call of Rev. Sarah C. Green:

Management and Administration chair Elder Kevin Hubbard explained to the congregation that ordained pastors are called into a relationship with a church by the congregation and the congregation must be the body that approves dissolving those terms. He further explained that today is Pastor Sarah's last day of ministerial duties at PCM. She will remain in our employ as she completes two weeks of paid vacation making her last day at PCM February 28, 2022. MOTION to dissolve Rev. Green's TOC, seconded, and APPROVED. Pastor Leslie acknowledged all the help that Rev. Green's many gifts and strengths have provided. (See Appendix III)

A **MOTION** was made to suspend the Congregational meeting to then conduct the Meeting of the Corporation and resume the Congregational meeting at its completion, **APPROVED**.

Upon the suspension of the Congregational meeting, Rev. Dobbs-Allsopp turned the meeting over to Elder Sue Wood, outgoing President of the Corporation.

<u>Part II</u> <u>Corporation Meeting</u>

RECOMMENDATION FOR THE ELECTION OF OFFICERS AND REGULAR BUSINESS TRANSACTIONS FOR THE CORPORATION

- I. The Meeting of the Corporation was called to order by Elder Sue Wood, President of the Corporation. She explained that the purpose of the meeting was to elect our corporate officers. This is necessary as these individuals act on the behalf of the church as signators.
- II. Elder Wood presented recommendations for the election of officers and for regular business transactions of the Corporation, explaining that by virtue of committee or office, the officers are thusly determined: Elections of Officers of the Corporation to serve until the next Annual Meeting are: President Chairperson of Finance, Walt Fleischer, Vice President Chairperson of Buildings and Grounds, Christy Allison, Secretary Clerk of Session, Wendy Doidge, Treasurer Karen May.

MOTION to accept the slate of officers of the corporation for 2022, **APPROVED**.

There being no further business for the Corporation, the meeting of the Corporation was adjourned. Attested to:

XI. Resolution of Thanks for Officers Completing Terms of Service

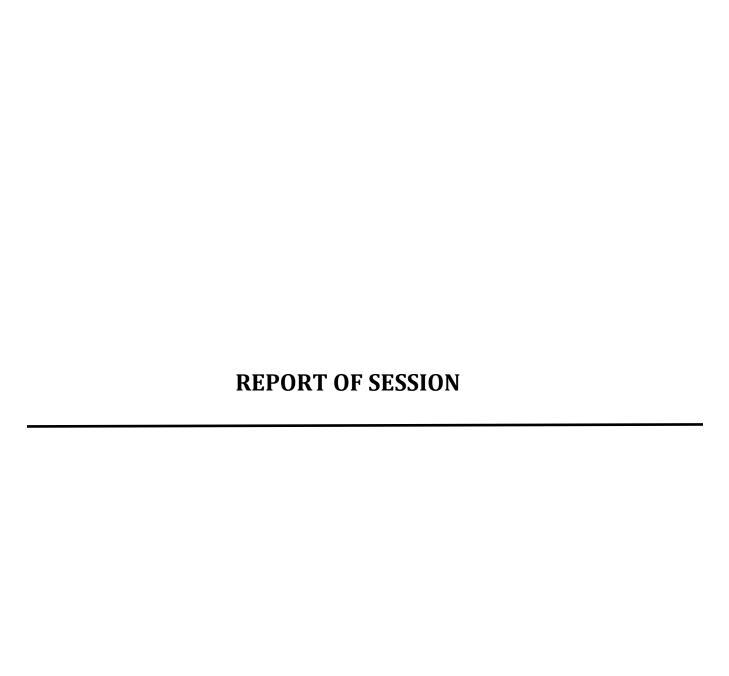
Rev. Dobbs-Allsopp thanked the elders and deacons who have so aptly served our church during a very difficult time.

Buildings and Grounds Committee

Mission Statement:

The mission of the Buildings & Grounds Committee is to create a safe and enjoyable environment where disciples can grow, and the Kingdom of God can be proclaimed and effectively built. We do this by maintaining, preserving and improving while retaining the historic nature of our church buildings and grounds so they will continue to facilitate the needs of our congregation and community. It is also our purview to establish policies for facilities use and access.

Introduction:

The committee is responsible for our facilities and grounds including the Church on the Green, Chapel, Howard House, Parish House, Manse, Sexton's Cottage, the historic Burying Ground which also incorporates our Memorial Garden, landscaping, and parking lots. Over the past year the Buildings and Grounds Committee continued with our focus on the exterior preservation, water management, and repairs at the facilities. The committee's work is funded by the annual budget and endowment fund, and our work is supported by Paul Koski, our Director of Administration, who is a staff member of the committee, and who manages the Sexton (Kristo Pango), janitorial staff, and day to day building operations and emergencies for all of the buildings and grounds.

The committee has utilized the Master Plan prepared by the architectural firm, Connelly & Hickey, in April of 2011 as a guide to prioritize maintenance work on all our facilities. The work of caring for our buildings and grounds requires a great deal of time, the committee members are dedicated to this work and spend many hours managing the projects listed below. I am so grateful for this group of individuals and the work they do for our congregation.

Significant Achievements in 2022:

General Administration

- We organized a spring clean-out, providing an opportunity for all committees and programs to get rid of broken and unused items (from all buildings).
- We conducted an assessment of the cleaning services for our spaces, finding that we have about a 12-hour per week gap between all the cleaning tasks that would ideally be done and what our current contract supports. As no additional resources were available, we developed a rotating priority list to ensure all cleaning tasks are done to support Mission and activities.
- We conducted a space utilization assessment, which helped identify when and where we
 have capacity available. This assessment also informed a new approach to budgeting that
 allowed us to assign overhead costs to programs.

 The Operations Subcommittee approved the use of a new fee schedule on a trial basis for three months to ensure that all external building requests that are granted cover all of our actual costs (direct and overhead), and also contribute to capital improvements for for-profit groups/fee-charging events.

Church on the Green/Chapel

- We had a number of repairs to the COG boiler to maintain it in working order.
- We replaced portions of the sidewalk in front of the chapel and COG tower entrance.
- With support from the Harris wedding gift, we restructured the entrance to the chapel, ensuring its integrity and safety. We repainted the doors and vestibule. We also contracted to replace the vents to reduce the possibility of animals intruding into the attics.
- We upgraded our fire suppression system from landline to cellular.
- We maintained the grounds and removed the overgrown cypress trees by the chapel entrance and the overgrown redbud trees by 1776. We also did limited pruning in the burying ground.
- We replaced one of the exterior LED floodlights that was vandalized.
- We temporarily repaired ten entry points where raccoons and squirrels were able to enter the attic through rotted soffits.
- The committee worked with Connolly and Hickey to develop a bid package for the refurbishment of the COG roof (soffits, flashing, underlayment, and a limited number of slate tiles), and we received one bid for the work. With the congregation's approval, work will commence in 2023.
- AAA addressed all pre-fire inspection issues.
- AAA repaired the window in the bell tower.
- AAA repaired the door closers on post office side COG door and vestry door.
- AAA repaired the combination lock on the closet in women's restroom.
- AAA repaired and painted window well covers.
- AAA filled potholes in the COG driveway.
- AAA posted height restriction signs at COG driveway entry to protect Howard House gutters.
- AAA repaired the door frame on the sign cabinet on the exterior tower wall.
- AAA repaired four electrical outlets.
- AAA repaired and replaced the tower clock mechanism.
- AAA installed/uninstalled screens on the sanctuary windows.
- AAA cleaned and painted wood window covers.
- AAA constructed a concrete lip around the Bilco door foundation to divert water from entering basement on the Chapel side driveway and painted the door.
- AAA took down the 2021 Christmas decorations in the sanctuary and put up the 2022 Christmas decorations.
- AAA replaced the Tiffany Cross lights and cleaned the glass.
- AAA rewired the exterior lantern on the post office side.

Parish House

- The Parish House steps were replaced, ensuring the safety of members, staff, and visitors while maintaining its historic nature.
- We replaced the air handler control panel on the HVAC system.
- We had all the windows and carpets cleaned.
- We maintained the grounds.
- We upgraded our fire suppression system from landline to cellular.
- The water supply lines (general and fire suppression) from the water main to the building were replaced by the town.
- We replaced the check valve for the main water line.
- B&G supported the Nursery School with the installation of air conditioning units in two classrooms.
- AAA painted the windowsill and one baseboard in the office, the basement stairwell, the door to room 21/22, and the ramp handrail.
- AAA replaced broken molding on ramp door frame, patched cracks, painted the door, and removed the old doorbell.
- AAA flushed and sealed the kitchen floor traps.
- AAA resecured the heat cabinet grills in South Street Hall.
- AAA repaired and painted window well covers.
- AAA repaired an outlet in room 21/22.
- AAA repaired broken fencing around the air handler equipment in the side yard outside the kitchen.
- AAA hung pictures in the stair well on the 2nd floor.
- AAA installed casters on a cabinet and replaced broken coat hooks on a rolling back-pack cart in Nursery School room 2.

Howard House

- We had the gutters redone to prevent trucks exiting the parking lot from hitting the leaders and damaging the gutters, compromising the drainage around the foundation.
- We cleared the third-floor apartment after the Allred family moved out and prepared it for the Webber family to take residence. AAA repaired the toilet, fixed a broken window, and painted the apartment. We also replaced the washer, dryer, and dishwasher in 2022.
- We repaired the basement ceiling and HVAC ducting that fell down from the joists.
- Several tenant agreements expired in 2022, and we negotiated the expansion of Nourish NJ's agreement to partially take up the available space.
- AAA repainted the porch.
- AAA repaired and repainted four broken banister spindles.
- AAA addressed a malfunctioning light by the garage.
- AAA repaired and repainted two broken windows.

Manse

• We replaced the French drain in the manse basement, ensuring it is dry for the first time since its construction.

- We replaced the manse boiler to update the heating system prior to the new head pastor taking residence, which should generate a 30% savings on heating.
- We cleaned, repitched, and installed screens on the gutters to improve management of drainage.
- We repainted five rooms to prepare the house for the new residents.
- We maintained the grounds and removed the broken fence, and AAA removed the old fence posts around the back side of the property.
- AAA screwed down the loose deck boards on the back deck.
- AAA replaced the PVC elbow on the downspout.
- AAA replaced two joist supports in the basement.
- AAA repaired nail pops in the family room ceiling.
- AAA trimmed and adjusted two interior doors.

Sexton's Cottage

- We replaced the cracked gas line between the PH and the cottage.
- We rebuilt the chimney from the roof up and installed a stainless steel chimney liner and cap to ensure that gases exhaust appropriately and carbon monoxide is not released into living spaces.
- We contracted to have the attic window replaced.

Safety Ministry Team

- Bob Davies continued to provide leadership over this Team focusing on education and awareness of the congregation and staff regarding safety in 2022. This included conducting CPR and AED training, developing training materials for the Welcome Team, and updating the congregation (via Tower Tidings) on security and safety enhancements in place following resumption of 'in person' worship.
- In addition to Bob, in 2022, the Safety Ministry team members included Christy Allison, Chris Crean, Kevin Hubbard, Dick Kaller, Paul Koski, Nancy Shearer, Jenny Tooley, and Sue Wood.
- The following people served as Medical Commanders during worship: Anna Alessio, Chris Crean, Theresa Crean, Patty Scaduto, Phil Scaduto, and Melissa Warta.

Ongoing Efforts:

- Manage costs by reviewing maintenance contracts and minimizing costs while preserving quality service.
- Anticipate and plan for major maintenance and capital improvement projects that will prevent deterioration of our properties and improve utility and support for our Mission.

Acknowledgements:

The Buildings and Grounds Committee would like to especially thank AAA for its support this year. AAA completed an estimated 50 projects, accounting for 1,200 volunteer hours and saving the church an estimated \$86,868. We are grateful to the Safety Ministry Team for its continued work, to our Medical Commanders for their support, to Paul Koski for his leadership in operations, and to Kristo Pango and Cory Villeneuve for their continued

dedicate in caring for the church's facilities. Special thanks to Chris Crean for providing CPR and AED training. We would also like to thank all the staff and volunteers who helped monitor our buildings when our fire suppression alarm system was malfunctioning.

Mission statement:

The Finance Committee oversees and analyzes all financial, budget and investment matters relating to PCM, including monitoring the overall financial needs and health of the church. The Finance Committee provides oversight and guidance to the other Session committees, often through the Treasurer, on committee fundraising efforts, budgeted expenses, and the preparation of annual committee and PCM budgets. Final disposition of all financial matters rests with the Session, except as may be delegated to the Finance Committee either in the Session-approved Finance Committee Manual or on a case-by-case basis.

Summary and Overview:

2022 was a difficult year financially for the church. Pledges were under budget. However, expenses were slightly lower than budgeted and donations were a little higher than expected, and so this resulted in a smaller overall budget deficit. The financial markets had a very rough year, one of the worst ever. While investment returns for the PCM Endowment were down, they were better than benchmark returns (PCM investment performance was down 11.9% vs benchmark performance of -15.3%) thanks to a sound, diversified investment strategy adopted by Finance and implemented by PCM's investment advisor, Mariner. Budgeted and actual withdrawals from the Endowment were higher than in 2021, in which year PCM was aided by a substantial PPP loan (since forgiven). Endowment withdrawals going forward are expected to remain at unacceptably high levels, requiring longer range plans to increase pledge and other income, to reduce expenses, or both.

Significant Achievements in 2022:

- Obtained Session approval of the 2023 PCM budget. The 2023 budgeted Endowment withdrawal is \$694,758 to support PCM operating deficit and major building maintenance costs. This number is substantially higher than the maximum \$400,000 withdrawals suggested by PCM's financial advisor, Mariner, using various future market scenarios and assumptions, to maintain the Endowment over a 25- year period. A comprehensive review of PCM's overall financial condition was presented for information and discussion to Session in the Fall of 2022.
- The Committee met with and accepted the 2020 audit report of the external audit firm, Nisivoccia, LLP. The report showed no material weaknesses in PCM's financial statements or controls.

- In March 2022, \$50,000 which had been donated as a separate part of the 2022 Stewardship campaign was turned over to The Presbyterian Church Nursery School. Some of this money has been used by the school to install air conditioners in several of the classrooms, and the balance will be spent as determined by the school's director and advisory committee.
- At the suggestion of Finance, in June 2022 Session adopted a new alcohol policy for PCM. Previously, only beer and wine were allowed on PCM premises. The new policy expands that to include all alcohol, but only in conjunction with third-party events in the Parish House and as approved by Session on a case-by-case basis. The purpose for this change is to encourage greater use of the Parish House for events such as receptions and dinners, to raise money through such use, in conjunction with an agreement signed in 2021 with an event coordinator, Kraft Event Management.
- The Committee met several times with PCM's investment advisor, Mariner.
- In October, the Committee approved and submitted to Session an updated Finance Committee Manual.
- PCM insurance costs have been rising in recent years. In 2022, the Finance Committee engaged the services of a second broker, AON, to market our coverage, in competition with the broker PCM has used for many years, Brown & Brown. Because PCM owns unique historic properties, with very valuable contents, placing our coverage is difficult with a very limited number of prospective insurers in this market. Our 2022 insurer, UFG/Mercer, is exiting the market. In December, through Brown & Brown, we obtained coverage for 2023 from GuideOne, at a premium increase of about 10% over our 2022 premium.

Ongoing Efforts:

- In 2022, the Finance Committee initiated a Long-Range Planning Group to address the committee's responsibility to consider the financial needs of the church and develop long-range plans to meet those needs. This Group met several times in the first half of 2022 and will resume its work in 2023. A principal goal of this Group is to develop a strategy to reduce annual Endowment withdrawals supporting operating deficit and major building repairs to less than \$400,000, in keeping with Mariner's recommendation.
- In 2023, the Finance Committee will consider new strategies in an effort to reduce our insurance spend.
- In 2021, and in prior years, annual audits of PCM's financial affairs were performed by members. Such audits are conducted as required by PCM bylaws, which provide for them to be performed by an audit committee composed of members of the congregation. At the direction of the Finance Committee, the most recent two audits were performed by an outside firm, Nisivoccia, LP. This was done to obtain a professional opinion that PCM's substantial financial affairs are being handled appropriately. In fact, the results of both external audits (for 2019 and 2020) confirmed that there were no material weaknesses in PCM's financial statements or controls. Beginning in 2022, and going forward, Finance decided to return to prior practice and the audit performed in 2022 (for 2021) was done by members. This audit again showed that PCM's financial affairs are being handled properly. The use of

- member-auditors not only saves the expense of the outside audit (nearly \$10,000), but Finance believes the information obtained through internal audits may be more useful.
- In 2019, an examination of the roof at the Church on the Green revealed the need for major repairs, to the dormers, gutters, and associated areas. Fortunately, the slate roof itself still has another 20-40 years of useful life. Largely due to Covid, these repairs were delayed. The cost for this work will be in the area of \$1 million. In 2022, the Finance and Buildings & Grounds Committees jointly met several times to review the need for this work (to preserve the sanctuary ceiling and the interior of the sanctuary, following the substantial investment made recently to renovate this space) and how to pay for it. We are presently exploring a low-interest loan through PC USA and envision the work being done in 2023.
- In 2013, a fund was established under the will of George Eklund on behalf of him and his late wife, Shirley, to provide scholarship assistance to members for higher education. In 2022, the Finance Committee approved an expansion of the qualifications for the Eklund Scholarships, to allow awards for graduate studies in addition to undergraduate work. The Scholarship Subcommittee will continue to administer this fund on behalf of the Finance Committee and will seek to determine how more applicants can be served.
- The revitalization of the Mutch Society. This is PCM's deferred giving effort, whereby members are encouraged to provide bequests to the church in their estate planning. Such bequests have provided a substantial portion of the Endowment, which in turn helps fund the ongoing work of the church.

The Committee recognizes the contributions of each Finance Committee member, in particular the work of Bruce Fisher and his advice overseeing the investment portfolio; Greg Hummer, and his assistance in insurance and matters relating to the potential financing for the roof repairs; Dick Kaller, who leads the AAA team of retired members who perform numerous maintenance and repair tasks, saving substantial costs for PCM; as well as non-members Marcia Heiden, chair of the Scholarship Subcommittee; and France Delle Donne, who ably led the 2023 Stewardship Campaign with great enthusiasm and skill.

A special thanks to Karen May, PCM's volunteer Treasurer. As she has done for many years, in 2022 Karen spent countless hours preparing monthly reports for Finance and Session, headed up the audit, maintained PCM's banking relationships, and was principally responsible for preparing PCM's annual budget.

And thanks to Henry Ahlers, PCM's Finance Administrator, whose work includes the day-to-day management of the church ledger and accounts, and who sees to it that the bills are timely paid.

Mission Statement:

The Outreach Committee provides community service in support of those in need. We offer that support through volunteer action for people of all ages and abilities and direct financial support to organizations that share our commitment. The Outreach Committee promotes building personal and institutional connections between our church, its members, and local and international groups. We strive for diversity and inclusion as we treat all people with respect and understanding, carrying out the directive of Jesus Christ to "love one another."

Introduction:

In 2022, we saw the outbreak of war in Ukraine, gas prices go up and inflation increase the cost of food and housing. Our Outreach ministries continued to address important issues of hunger, housing, and poverty with the help of church supported organizations and volunteers, and with generous donations from the congregation through the year. We ran donation drives to stock local food pantries, provided clothing, and necessities to those in need; and provided volunteer programs to serve meals, work at food pantries, and assist with holiday food and gift programs. The Outreach Committee initiated a fundraising drive to support the people of Ukraine affected by war, and funneled the money raised through Presbyterian Disaster Assistance, which was able to quickly put together on-the-ground assistance in Ukraine and Poland. In addition, Outreach provided educational opportunities for the congregation to learn and enrich their understanding of international Christian fellowship through the re-established Nairobi Partnership, and World Communion Sunday.

Significant Achievements in 2022:

- On Pentecost Sunday, June 5, 2022, PCM celebrated the renewal of our sister church
 partnership with Eastleigh Presbyterian Church of East Africa in Nairobi, Kenya.
 Our two churches exchanged videos to share with each congregation. Special music,
 African refreshments, displays, balloons, and beaded key chains and bracelets added
 to the celebration. The PCM Partnership team is comprised of Karen Brunner,
 Gretchen Donor, Bruce Frazier, Marnie Kaller, and Leanne Rea with Patrick Allred and
 Audrey Webber as advisors.
- On October 2, 2022, members celebrated **World Communion Sunday** by sharing breads from around the world, one of the most basic of foods, and its variety, representing differences and similarities around the world.
- The Committee **involved Sunday school and church youth groups** in various Outreach programs to encourage community engagement at an early age, to foster intergenerational ministry, and to create lasting relationships across all ages.
- We committed to helping support **Cohome**, a Morristown organization that operates an inclusive home for people with disabilities and their peers to live together as housemates. Their mission is to provide residents an opportunity to live in a community where they can walk to jobs and interact with those who can help with their challenges. In December, some of the residents went to the United Methodist Church to share a Christmas party with The Children on the Green.
- Outreach initiated a **fundraising drive to support the people of Ukraine** affected by the war. Thanks to the generosity of the congregation, over \$9,500 was collected along with a donation of \$5,000 from the Outreach Committee to assist war refugees or people staying at home and in need of food, safe shelter, and supplies for life.
- PCM members were offered the opportunity to volunteer to serve meals to-go for those in need at **Table of Hope** one Wednesday per month from June through December.

Ongoing Efforts:

- Outreach presented "Moments for Mission" almost monthly to keep the congregation aware of the organizations that we partner with to meet Christ's directives to love and care for all people. Many thanks to so many who helped!
- With the onset of the Covid pandemic, nourish.NJ had to change how to serve guests and Breakfast Bags were instituted. Outreach committed to 50 Breakfast Bags per month and volunteers to provide these bags on the fourth Thursday of each month. Volunteers can once again help by handing out the prepared Breakfast Bags and lunches.
- Morris Area Together continues to advocate for those in need of housing, criminal justice, and mental health/substance abuse issues. Because of last year's push, some positive changes have been made in Manahan Village. Work is ongoing to improve ModivCare, the non-emergency transportation for Medicaid patients. The criminal justice team is now statewide and has worked to enforce the Fair Chance Housing Act. They have also influenced the Prosecutor to implement much more Crisis Intervention Training for employees.
- Interfaith Food Pantry Network (IFPN) Spring and Fall Food Drives: Outreach ran two Food Drives for IFPN. The spring food drive collected 509 lbs. of food items and \$2,275. The fall food drive collected 757 lbs. of food for Thanksgiving dinners and \$1.280.
- Outreach offers PCM members the opportunity to volunteer at the **Table of Hope** outdoor food pantry one Thursday per month. Members help serve 500 people in need of food.

- **JBWS (formerly Jersey Battered Women's Services)** Outreach ran a donation drive to include small groups, Circle 12, and the PEO in June to help victims of domestic abuse. We collected cases of food, diapers, and toiletry items for JBWS.
- Market Street Mission (MSM) Summer 5 K Race for Recovery and Fall Coat Giveaway

 Outreach assisted MSM on July 4th with setting up a picnic after their annual "5K Race for Recovery" fundraiser for 70 men in their Men's Addiction Recovery Program. In October, Outreach ran a Coat Drive and collected 124 new and gently used coats to help the Market Street Mission with its 32nd annual Coat Giveaway on November 5th.

- **Diversity Coalition of Morris County (DCMC)** The DCMC held Diversity Day on the Morristown Green featuring an interfaith service, music, and food led by local organizations. The Outreach Committee set up a display table featuring PCM information and children's activities for visitors of the event, held on July 10.
- **Table of Hope Donation Drive** Outreach ran a donation drive for Table of Hope in September to collect "Commercial Sized" supplies to help feed those in need in Morris County. The drive collected 6,842 food serving items and donations of \$700.
- Operation Love For 38 years, PCM and the Church of God in Christ (COGIC) have partnered to help Morris County families and seniors celebrate Christmas with food and gifts. This year the congregation donated \$5,310 in gift cards in addition to our annual Outreach donation of monetary support for Operation Love. PCM and COGIC members also volunteered to wrap and deliver gift bags to 212 recipients.

 home baked cookies to the staff and inmates (an inmate favorite!).

• One Great Hour of Sharing (OGHS) and Christmas Joy - These two Outreach programs collected: \$6,243 for OGHS and \$2,250 for Christmas Joy.

- **Disaster Assistance** Outreach provided funding to two Presbyterian Disaster Assistance Efforts PC USA disaster relief efforts in 2022:
 - Kentucky Flooding Donated \$1,000 to aid people without water and power from the Kentucky flood in July.
 - War in Ukraine Donated \$5,000 to deliver aid to those impacted by war in Ukraine.

Introduction:

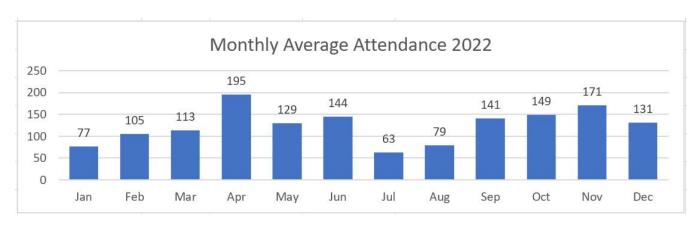

Significant Achievements & Ongoing Efforts:

Daniel Vigilante as Senior Minister and Head of Staff and had the pleasure of hosting his Installation Service on October 23, 2022. We are thrilled to work with Audrey and Daniel and look forward to their leadership in the years to come.
- In November we hosted the world-renowned Tenebrae Choir from the UK to a packed house of attendees.
- We celebrated two Christmas Eve services in the Sanctuary, at 4 and 8pm, and a Christmas Day Carols and Brunch service at the Parish House.

- The high school and middle school youth programs continue to meet weekly throughout the year.

REPORT OF PROGRAMS AND ORGANIZATIONS

THE BOARD OF DEACONS

Moderator: Carol Johnson

Mission Statement:

The Board of Deacons is responsible for the ministry of congregational care and to nurture the church family in love and faith as guided by the scriptures.

Introduction:

The ministry of Deacons as set forth in Scripture is one of compassion, witness and service, sharing in the redeeming love of Jesus Christ. The primary responsibility of each Deacon is to care for one or more members of the congregation as assigned by Staff leadership. Deacons strive to make personal contact with their "Concerns" at least once a month and to keep them as closely connected with the church as possible.

Significant Achievements in 2022:

- Deacons began the year having an activity to get to know one another and reviewed information on how to connect with our concerns especially with Covid concerns still limiting visitations. Meetings continued to be held on Zoom through June of 2022 and we looked for ways to connect and get to know one another.
- In September the Deacons returned to in person meetings and held sessions with Audrey Webber on how to pray and how to participate in serving Communion with our concerns.
- The Deacons conducted worship services at Spring Hills in February, June, October and December, holding 2 services a month which had also been cancelled due to Covid outbreaks at Spring Hills. The schedule has changed and continues to evolve due to a change in participating churches and their scheduling requests.
- Deacons, along with other members of the congregation, continue to send cards to residents at Spring Hills – for Valentine's Day, Easter, Thanksgiving, Christmas, as well as spring and summer thinking of you cards.
- Deacons were once again each assigned approximately 20 member households who live in New Jersey to act as their Deacon. Letters were sent to the household explaining the role of the Deacon letting them know they could contact their Deacon for such things as a hospital visit, a prayer concern or joy to share, transportation to church services or finding information about the activities in our church. We also sent information on Easter services. Many favorable comments were received about re-instituting this assignment.
- Easter Flowers were delivered to concerns after the service.
- In-Reach Day consisted of volunteers who helped three households with outdoor jobs the last Saturday of October.

- Fall Seminar was also held in October. The topic was "Hospice Care" given by Rhonda McMann. Thirteen members of the congregation attended and found the information very helpful in determining what Hospice Care can provide and when it should be considered to improve the quality of life in the final stages.
- Thanksgiving "gift baskets" of fruit and snacks or plants were assembled individually by the Deacons and delivered to Concerns.
- A Holiday get together was held at the home of Tom Guthrie. It was the first social activity since Covid. Both the current deacons and the nominees for the class of 2026 attended. It was a wonderful opportunity to get to know one another.

Ongoing Efforts:

In addition to the primary responsibilities discussed in the introduction, Deacons also are responsible for the following *traditional* activities:

- Deliver flowers and a Sunday worship bulletin each week to church members who
 are hospitalized, in a rehabilitation facility or confined to their homes. We are once
 again going to hospitals and rehabs and we also deliver to the home when members
 come home from the hospital. We have also delivered to people who have difficulty
 attending services or have had a death in the family to let them know we are still
 thinking of them.
- Maintain the Deacon's closet which has wheelchairs, walkers, crutches, etc. which can be borrowed for a Concern or anyone in need of the items.
- Distribute *The Upper Room*, a bi-monthly devotional booklet, to our Concerns. These are currently mailed by the church office.
- Coordinate and assist with the worship services at Spring Hills Assisted Living
 Facility in February, June and October. We are now doing only 2 Sundays each month
 so we are looking into additional months for this year we added one week in
 December.
- Serve communion each month along with Elders and assist in the Maundy Thursday worship service.
- Represent the Deacons at the monthly Session meeting to report on our activities and represent Deacons on the Safety Committee and Nominating Committee. Since September, the report to Session has been sent in advance of the meeting rather than being read by a Deacon at the meeting.
- Distribute Easter flowers to Concerns and others in the congregation who wish to receive them.
- Coordinate and participate in the annual In-Reach Day.
- Host a Fellowship Hour. This year we hosted on June 19, 2022.
- Assemble Thanksgiving baskets or plants and deliver to our Concerns.
- Remember Concerns on their birthdays with a card.
- Participate in on-going education to better equip ourselves for helping those in need.
- Provide transportation to those needing rides to worship services.
- Present a program of interest to the congregation.

Mission Statement:

Our goal is to provide children with a foundation of skills to use throughout their lives. We offer the children an opportunity for emotional, physical, intellectual, social and spiritual development in a Christian environment. We serve children and families in the Morristown community by establishing a nurturing and stimulating atmosphere for young children.

Introduction:

We are responsible for the operation of the Presbyterian Church Nursery School. We report to the Christian Education Committee.

Significant Achievements in 2022:

- The school continued to persevere through the pandemic protocols and the children thrived. Children and staff wore masks until March 7, 2022 removed them once the Governor lifted the mask mandate. We had another year end outdoor celebration with ice cream, children singing and general fun for all on June 10.
- The school obtained a Stabilization Grant, offered by the state of New jersey to licensed childcare organizations intending to help them stay open. Staffing and school population continue to be a problem in the childcare industry and these funds help schools function.
- Additionally, a Staff Retention Grant was awarded, and all teachers received a \$1,000 bonus. In order to be eligible, all staff completed trainings offered by the State of New Jersey Office of Licensing.
- Stewardship funds provided Air Conditioning units for classrooms 1 and 2!! This was a tremendous improvement for staff and students!!!
- Staff hired for 2022/23 school year included: Kristen Singaliese, Robin Fitzgerald, Louise Russ, Jennifer Oberding, Amy Mehl and Karen Healy. A new substitute teacher joined the staff – Lori Ann Giardina.
- Jeanne Mueller remained as director and was able to have all classrooms fully staffed for the first time in over two years.
- Staff who left our school Megan Adair
- Registration for September continues to be lighter than usual.

- The school welcomed three scholarship students in 2022/23 school year. Preschool Advantage is supporting these students.
- Our "Brightwheel App" has increased our ability to communicate with parents and upgrades in billing process facilitated quicker payment of invoices. Parents and staff are enjoying this feature.
- The school is using a new cleaning company, Sanicare Cleaning Solutions to handle daily cleaning of classrooms and 2 school bathrooms.
- After-school enrichments continue: Wee Little Arts, Little
- Hearts Yoga, Miss Carol's Sports and Games class, Garden Club, and Dance with Miss Megan (a new class this year)
- In School enrichments continue: Yoga, Music with Mr. Patrick, Bible Story with Mrs. Mead and Gym class with Miss Carol are offered to the school community during the school day.
- JAM (the church music program started by Julie Ramseyer is still not running much participation in it may cause cancellation of this program.
- Weekly emails continued to be sent out to parents by the director through Mail Chimp.
- Parent Education Events returned this year. The school welcomed events for Occupational Therapy and Early Childhood Behavior for school and church families. The school will also participate in the Spiritual Child event sponsored by the church.
- Breeze the church database, assists with emails to families and alumni and for fundraisers, registration, enrollment forms and joining parent activities and events.
- Relicensing Year the school completed its relicensing requirements, and the Office of Licensing, Department of Children and Families approved our license. The license expires in March of 2025

Ongoing Efforts:

- The school website at www.pcnsmorristown.org continued to be a source for information for new families interested in our school as well as information for current families.
- Our social media imprint has increased with our new Instagram account. This will help us raise our profile to reach new families
- Connections with local schools like Peck School and Red Oaks School will help us connect with other families looking for preschools.
- An Open House is planned for February with staff and parent assistance to increase our outreach for new families
- A summer camp will happen in July and August! PCNS is launching a 4-week initial offering of summer camp for 30 children ages 3-5.

Acknowledgements:

The school would like to thank first and foremost our sponsor from the Presbyterian Church in Morristown – Vicky Willson. We lost Vicky suddenly in September and this loss is immense for the school staff. Vicky served as chair of the Advisory Committee for many

years and was part of the committee for over 40 years. The school is so grateful for her assistance, comradery, and leadership. She is sorely missed.

To the Members and Friends of The Presbyterian Church in Morristown:

2022 Annual Report of the Treasurer

The pages of this report will detail the Church's financial activities in 2022. A narrative summary is shown below.

Operating Results:

Our Operating Results were very slightly favorable compared to the 2022 budget. This was due to several things.

- Pledges fell short of our \$850,000 pledg goal. Our pledge receipts were \$770,697 which is about \$79,000 lower than budget.
- Member Unpledged donations were slightly below budget, but Non-Member, Plate and Misc Income were above budget
- Outreach and W&M were below revenue budget due to less individual contributions than expected.
- Overall Revenue was \$29,560 under budget
- On the Expense side, we had a favorable variance of \$31,476
- This was mainly due to M&A expenses being below budget due to unfilled staff positions at the beginning of the year. This was offset by higher than expected expenses in Music and Community and Membership. C&M was over budget due to midweek meals now falling in this committee with the budget in Christian Ed.
- Our net results were \$1,916 favorable compared to budget.
- Note that the Church's Operating budget is compiled at a loss and makes up the shortfall with an annual withdrawal from the Endowment. See below for more details.

Major Maintenance:

• In 2022, the church continued to invest in and maintain our 5 buildings. The total cost of expenditures for Major Maintenance in 2021 was \$67,700. Major projects include reconstruct of Parish House steps, new boiler at Manse, replacement of gutters at Howard House and repair of Chapel steps.

Endowment:

Our budgeted withdrawal from the endowment for 2022 for the **Operating Budget, Major Maintenance and Special Funds** was \$593,518. Actual withdrawal for these categories totaled only \$578,293. We received bequests of \$198,983. It was a tough year for investments. Our Endowment fund lost 11.9%, equating to about \$1,148,000. Please see the Endowment schedule for further information on these withdrawals.

2023 Budget

The 2023 Budget is available on a separate sheet. Our pledge budget is lower for 2023 at \$800,000 reflecting the lower trend of the past few years (side note: there's still time to pledge!) Thus far we have received approximately \$722,000 in pledges. This may impact our ability to expend funds as per the 2023 expense budget if additional pledges are not received. Expenses are expected to be higher in 2023 due to all staff positions being filled and rising insurance costs.
