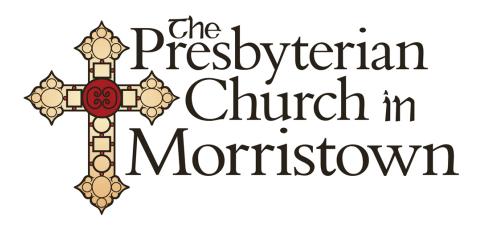

REPORT OF THE PASTOR:

I would never call myself a "numbers" guy - I was always much better at reading and writing than math and science. But there's something about numbers that pair well with an Annual Report. Numbers don't lie - and they often tell a story - and I'm excited and proud to say that our numbers over the last year at PCM tell a compelling story about what we've accomplished over the last 12 months and where we're headed as we look to the future...

Thirty-One: That's the number of new members who joined PCM in 2023. From families with young children looking for a place to teach their little ones the Christian faith to older adults seeking companionship along the journey, we have been blessed with wonderful people who have chosen to make PCM their church home. I am grateful and overjoyed to have them among us!

Five: Of the 31 new members mentioned above, five were part of our 2023 Confirmation Class. It is always an honor when students choose to affirm their baptism and profess their faith in Jesus Christ. Let's give thanks to God for each one of these special teens!

Twenty-Three Percent: The increase of in-person worship attenders over 2022. Worship attendance in December 2023 was up 47% over December 2022!

Fifty: The average number of people who comprise our online community. There is, essentially, an entire church-within-a-church of people who worship with us online! Isn't that incredible?

Nine Percent: The increase in pledges to our annual giving campaign over 2023. Many thanks go to those who made commitments for 2024, and especially to those who served on our stewardship team. Without your financial support, the various ministries of our church wouldn't happen.

Ten: The number of years remaining till PCM marks its 300th Anniversary! As we look to this historic milestone, we know there's work to be done to give this occasion the celebration it deserves. Not only that, we know there's work to be done to set a course for the future, which ensures PCM remains a vital congregation for generations to come.

As we begin this 10-year countdown to our 300th Anniversary, PCM is commissioning **Five** of its members to serve as the core of a Vision Team that will ask important questions over the next two to three years - things like - Who is God calling us to be? How are we going to continue serving Christ in Morris County and beyond? What's the best way to share the Good News in an increasingly secular world? What plans do we need to set in motion in the near term to make certain PCM is a healthy, strong, and vibrant Christian community for the long term? These five core members will be joined by representatives from the Deacons, Elders, and staff.

One way - perhaps the best way - to work toward our long-term success is to tell others about PCM and to invite them to attend. When people come to our church, we want them to receive a warm welcome - because it really is a privilege when anyone walks through our doors, but especially those who come to us for the first time. We want them to be moved by the music and the message. We want their children to have fun engaging with the stories or scripture. We want folks to feel like they have encountered God. We want people to have such a wonderful experience that they decide to return the next Sunday.

Numbers tell a story... and our numbers tell us that PCM is headed in a positive direction. While the story in so many congregations is one of decline in membership and giving, PCM is growing in number and in resources - Thanks be to God! Let's continue to build upon the successes we have achieved in 2023 as we look to a bright and hopeful future.

REPORT OF THE ASSOCIATE PASTOR:

As I reflect on this year, it has been my greatest honor to serve alongside you, and I cannot help but smile as I imagine each of your faces in my mind. One of my spiritual practices is to light a candle every morning to pray for each of you as we learn how to be the community God has guided us to be. As I lit my candle before beginning to write to you, I could not help but feel so blessed as you have called me to now be your installed Associate Pastor. I look forward to making that official soon, but in the meantime, my heart is full as I remember all the meaningful things we have done together. While many more highlights are noted below, I would like to voice my gratitude to each of you and our staff for working together on many new projects and continuing many of our beloved programs. I want to thank each of you for the generosity, love, and care you have shared with me in worship, our meetings, programs, and events throughout this year.

Congregational Care

Pastoral care continues to be one of my primary focuses. In this area, I have been working on building systems to reach all our folks well and to provide programs that fill in gaps in care as they arise. A few of the areas of focus around congregational care include:

- Meeting regularly with parishioners with acute pastoral needs and ongoing care.
- Working alongside our Deacons and Stephen Ministers and developing training for each group.

- Building our Sunday adult education program, "Doughnuts and Theology," to cover a wide range of topics and create a welcoming environment for participation.
- Creating our Art Team and curating four art shows and several other art making programs, including an art and faith series, a Bob Ross night, and incorporating art into worship.
- Creating our 2023 Lenten and Advent Devotionals.
- Developing relationships outside of the Church, including attending community events.
- Working with our Outreach Committee to continue developing relationships with the community and contributing to our events.

In addition to our work together, I am excited to imagine how we can continue to be the welcoming church PCM is called to be. May we continue to pray for each other and our community as we build new programs, have fun, and learn more about what it means to be God's modern-day disciples.

2023 Church Statistical Report

THE PRESBYTERIAN CHURCH IN MORRISTOWN, NJ ANNUAL MEETING OF THE CONGREGATION AND OF THE CORPORATION in the Sanctuary of the Church on the Green FEBRUARY 05, 2023

PART 1 Congregational Meeting

I. The Call

In accordance with the requirements of the constitution of the Presbyterian Church, USA, and the bylaws of the Presbyterian Church in Morristown [2E], the congregation was notified at least seven (7) days in advance of the meeting (in church bulletin, announcements in church services, congregational email, and on the church website) that "The Session of the Presbyterian Church in Morristown calls the Annual Congregational Meeting for Sunday, February 5, 2023, at 11:00 am"

The purpose of this Annual meeting is for the receiving annual committee reports, the presentation of the 2023 Budget, the review of the Pastors' Terms of Call, the election of Elder & Deacon nominees, selection of both a Nominating Committee and an Audit Committee, and other business which may rightly come before the Congregation." (G-1.0503)

II. The Meeting was called to order by the Moderator, the Rev. Daniel Vigilante at 11:04 am, and the convening prayer was offered by the Moderator. Conferring with the clerk, the Moderator declared there was a quorum present.

III. Minutes

The Minutes of the Annual Meeting of the Congregation and of the Corporation held on February 06, 2022, was presented to the Congregation. The Moderator explained that, in accordance with the Book of Order, the minutes of that meeting were reviewed and approved by the Session of the Presbyterian Church in Morristown (not the Congregation) at its first regularly scheduled meeting following the annual meeting, February 17, 2022. Copies of those minutes were sent electronically and available to all members for their review. Hard copies were also available in the sanctuary. No further action was required.

IV. Treasurer's Report – Elder Karen May

a. **Overview**:

This was a financially difficult year as we may know from our own finances. Our Cash/Investment position has weakened. Our investments were \$10.7 M as of 12/31/21 vs \$9 M today. The downturn in the market has caused a poor investment performance in 2022. There was a negative \$1.1 M and \$578K was withdrawn from the endowment for operations and major maintenance. About \$250,000 in bequests were received which were deposited in the Endowment and not used for Operating purposes.

b. Revenue/Expenses

Pledges fell short of budget by about \$79K (budget was \$850K and we received \$770K). The pledge shortfall was not due to people not paying their pledges rather an overly optimistic budget. B&G had strong revenue due to space rental and parking lot receipts. We had an unfavorable variance in revenue by about \$29K.

Expenses were favorable, mainly due to salaries coming in lower than budget due to open positions at the beginning of 2022, however this will change in 2023 as we are fully staffed. Overall, we had a slightly favorable variance compared to budget. Although we were within budget, we still had to take out \$578K from the Endowment to cover our operating gap.

<u>Endowment</u>: Endowment withdrawals in 2022 were slightly below budget. We withdrew \$578K against a budget of \$593K, however, this is still well above the withdrawal amount suggested by our Financial Advisor, Mariner.

Presentation of the Budget

The 2023 budget was approved by the Session at the December 15, 2022 meeting. In 2023 our expenses are expected to be higher by about \$125K. M&A is higher by about 13% due to our full slate of staff. The Communications Committee's budget is higher due to some new initiatives. The Finance Committee's budget is higher due to rising insurance costs. Due to these rising expenses, B&G pared back the Major Maintenance budget for next year.

Revenue will also be slightly higher. The pledge budget was lowered to \$800K. We have received over \$800K in pledges so that is a great start. Thanks go to the efforts of the Stewardship Committee and France Delle Donne. In 2023 we are budgeting the higher withdrawal of 694K from the Endowment which is expected to bridge the gap between budget and spending.

Overall Recap

Financial spending and discipline are needed to balance the needs of the church's short-term goals and the long-term strategy of maintaining our Endowment at a healthy level. In 2022 the Finance Committee initiated a Long-Term Planning Group to address the committee's responsibility to consider the financial needs of the church and develop long-range plans to meet those needs. This group continues to explore long term strategies to reduce our expenses where appropriate to ease the burden on the Endowment withdrawals. Ideally this process would free up more money for outreach and programs and limit administrative and building-related costs going forward. Good News – The size of our Endowment is still very healthy even though we took a hit in 2022 due to the market performance. We have an investment strategy with Mariner to balance long-term and short-term needs of the church to maximize investment income. This investment strategy helped shield us a bit from even more

losses in 2022. PCM performance was down 11.9% as the benchmark compared to a benchmark of 15.3%. Hopefully our sound investment strategy will take us through many years of shortfall.

Report of Audit

Through 12/31/2021

For 2021, the Finance Committee decided to switch from professional Auditors back to using Church Members. Our 2021 member volunteers were John Eyre, Rix Yard, Carolyn Crosthwaite, Sherry Guthrie, Larry McMillan, and Kevin Redgate (much thanks to these volunteers!). It was a savings of \$10,000.

More focused testing - This was a Transactional Audit rather than a traditional Audit. The goal of a transactional audit is not only to save money but also to focus the efforts more on the transactions of the church rather than a compilation of financial statements as a traditional audit would do. The Audit tested financial transactions of Church Operations, Endowment/Eklund Funds, Nursery School, and Presbyterian Women. Testing was done to determine accuracy, reliability, and proper authorizations of transactions in the general ledger. No major discrepancies were noted. **(See Appendix 1)**

V. Report of the Nominating Committee - Elder Dick Kaller Items for Action:

Elder Kaller had three (3) Motions to bring before the congregation. Voting for Elders and Deacons would take place in the same motion.

For the Session, Elder Kaller moved that on behalf of the Nominating Committee the Congregation accept the following candidates for election as Elders and as Deacons, in one motion, as indicated below:

<u>Elders, Class of 2026</u>: Rich Albright, Betty Darcy, Sherry Guthrie, Julie Hess, David Krimmel, and Linda Schober.

Elder, Class of 2024: Robin Ballard.

Rev. Daniel Vigilante, moderator, asked if there were any nominations from the floor. Seeing and hearing none, he reminded the Congregation that the **MOTION** came from the committee and did not require a second. This closed the nominations.

For the Diaconate Board, Elder Kaller moved that on behalf of the Nominating Committee the Congregation accept the following candidates for election as Deacons: <u>Deacons, Class of 2026</u>: Carl Bruen, Mark DeMos, Marilynn Harris, Lorraine Krimmel, and Leslie Mack.

Deacon Class of 2024: John Eyre.

Rev. Daniel Vigilante, moderator, asked if there were any nominations from the floor. Seeing and hearing none, he reminded the Congregation that the **MOTION** came from the committee and did not require a second. This closed the nominations. With nominations closed, and by a voice vote, the slate for Elders and Deacons as presented, were unanimously **approved**.

Elder Kaller expressed his thanks and appreciation for the work of the outgoing Audit Committee: Carolyn Crosthwaite, John Eyre, Sherry Guthrie, Larry McMillan, Kevin Redgate, and Rix Yard.

Elder Kaller made the Motion on behalf of the Nominating Committee: **MOTION**: The Congregation votes to elect members for the **2023 Audit** Team: Carolyn Crosthwaite, John Eyre, Sherry Guthrie, Larry McMillan, and Rix Yard. Rev. Daniel Vigilante, moderator, asked if there were any nominations from the floor. Seeing and hearing none, he reminded the Congregation that the **MOTION** came from the committee and does not require a second. Nominations were closed and by a voice vote, the slate presented was unanimously **approved**.

Elder Kaller expressed his thanks and appreciation for the work of the outgoing Nominating Committee: Elder (chair) Dick Kaller, Session representative Dianne Grenz, Deacon representative Helen Quinn and from the Congregation-at-Large: John Alessio, Ray Doidge, Jenny Fleischer, and Michele Yampolsky.

Elder Kaller made the Motion on behalf of the Nominating Committee:

MOTION: The Congregation votes to elect members for the 2023 Nominating committee: Elders: *Dick Kaller & *Betty Darcy, Deacon representative Christine Volinsky, Membersat-Large: John Alessio, Helen Quinn, Sheldon Rajkumar, and Pam Wood. (*Chair and Session representative, respectively).

Rev. Daniel Vigilante, moderator, asked if there were any nominations from the floor. Seeing and hearing none, he reminded the Congregation that the **MOTION** comes from the committee and does not require a second. This closed the nominations, and by a voice vote, the slate presented was unanimously **approved**.

VI. Report of the Management & Administration Committee

Elder Bob Spurr, committee chair, explained that unlike prior years, we would not be voting on the terms of call for Daniel and Audrey. The Congregation voted on terms of call for Daniel during his visitation weekend in June of 2022. At that time our discussions with Daniel included conditions that his terms of call would not be looked at again until the end of 2023. This was done primarily due to his start date being September first. A review of those terms of call are as follows: The effective salary is \$120,000 - \$85K cash salary and \$35K as manse value, the standard benefits package as required by the Board of Pensions and \$2,500 for continuing education, \$4,000 for travel/professional reimbursement, 4 weeks' vacation, and 4 Sundays off. There was also a \$15K moving allowance.

Our Nominating Committee sourced Audrey through the Presbytery's Covenant Supply Pastor process and negotiated her terms as a 1 year interim contract beginning on 26th July, 2022. These terms were reviewed and approved by Session. M & A will be looking

at this relationship again in the first part of this year knowing that the contract ends on the 26th of July, 2023. Her terms of call are as follows: Effective salary is \$81,000 - \$60K salary and \$21K value of the Howard House apartment, the standard benefits package as required by the Board of Pensions, \$6K for professional reimbursement with emphasis on being used in support of her pursuit of a PhD, 4 weeks' vacation, and 2 weeks study leave. Four thousand dollars of her salary was paid out in a lump sum to help defray the transition for living costs. Elder Spurr asked if there were any questions but there were none.

REPORT OF SESSION

Buildings and Grounds Committee Chairs:

Mission Statement:

The mission of the Buildings & Grounds Committee is to create a safe and enjoyable environment where disciples can grow, and the Kingdom of God can be proclaimed and effectively built. We do this by maintaining, preserving and improving while retaining the historic nature of our church buildings and grounds so they will continue to facilitate the needs of our congregation and community. It is also our purview to establish policies for facilities use and access.

Introduction:

The committee is responsible for our facilities and grounds including the Church on the Green, Chapel, Howard House, Parish House, Manse, Sexton's Cottage, the historic Burying Ground (which also incorporates our Memorial Garden), landscaping, and parking lots. Over the past year the Buildings and Grounds Committee continued with our focus on exterior preservation, water management, and repairs at the facilities. The committee's work is funded by the annual budget and endowment fund, and our work is supported by Paul Koski, our Director of Administration, who is a staff member of the committee, and who manages the Sexton (Kristo Pango), janitorial staff, and day to day building operations and emergencies for all of the buildings and grounds.

The committee has utilized the Master Plan prepared by the architectural firm, Connelly & Hickey, in April of 2011 as a guide to prioritize maintenance work on all our facilities. The work of caring for our buildings and grounds requires a great deal of time, the committee members are dedicated to this work and spend many hours managing the projects listed below. I am so grateful for this group of individuals and the work they do for our congregation.

Significant Achievements in 2023:

General Administration

• The Operations Subcommittee reviewed approximately 60 space utilization requests from individuals and outside groups and approved 22.

Church on the Green/Chapel

• We had a number of repairs to the COG boiler to maintain it in working order.

- We upgraded electrical components in the chapel and COG that were not compliant with code.
- In November, Alden Bailey commenced the COG Roof Restoration Project. The project will continue into 2024 and is expected to be completed in the springtime April-May. The general scope of the project entails new copper ridge and valleys for the roof and associated copper flashings. The (6) dormers will receive new flashing, slate for the roof and side wall areas, restoration of the windows and new decorative copper surrounds for the dormers. The lower portion of the roof had the slate removed for new weather protection to be installed, replacement of weather damaged underlayment, and repair and reconstruction of the rotted wood gutters, facia, modillions, and trim. New concealed copper gutters will be installed.
- As a result of a very generous bequest dedicated to a project associated with the Chapel, the Committee approved a window restoration project. The scope of this project is to restore the (10) windows located in the Chapel and investigate the dormer awning windows and their functionality, to determine if additional fresh air flow can be achieved. The restoration includes making the windows fully functional, new frosted glass, and reglazing. We have selected a contractor for the project, David Greene Construction, who was referred by Connelly & Hickey. We are in the process of selecting a glass manufacturer to replace existing frosted glass. The commencement of this project will be in 2024.
- We maintained the grounds and did limited pruning in the burying ground.
- On the weekend of Memorial Day, PCM hosted the Morristown chapter of the Daughters of the American Revolution to honor church member and Revolutionary War surgeon Jabez Campfield with a new marker and DAR plaque. Dr. Campfield was a Morristown physician and lived in what is now known as the Schuyler-Hamilton house, the Morristown DAR chapter headquarters. The dedication ceremony was attended by more than 150 people and included Revolutionary War Reenactors from Campfield's Infantry unit along with a Revolutionary War fife and drum corp.
- Many gravestones in the Burying Ground were cleaned this year. On July 27th, PCM and the DAR hosted a Gravestone Preservation Workshop led by expert preservationist Jonathan Appell of Atlas Preservation. Around 75 people, including representatives of around a dozen graveyards, learned gravestone cleaning methods and watched restoration demonstrations. Members Susan and John Moschberger have cleaned 550 stones so far, removing dirt, lichen, and other growth to help preserve the stones and make them more readable.

Parish House

- The boiler system underwent a series of repairs to try to improve the management of heat in its various spaces.
- We maintained the grounds.
- AAA undertook a variety of painting projects at the PH this year.

Ongoing Efforts:

• Manage costs by reviewing maintenance contracts and minimizing costs while preserving quality service.

 Anticipate and plan for major maintenance and capital improvement projects that will prevent deterioration of our properties and improve utility and support for our Mission.

Mission Statement:

Encourage, increase and sustain the involvement of church members and prospective members by helping them find opportunities to feel a sense of belonging in our church family. Provide opportunities and encourage participation in gatherings outside of Sunday worship services, which are designed to address the needs of our diverse church community. Strive to increase the visibility of our church both within our church membership and also within the Morristown community at large.

Introduction:

In 2023, the Community and Membership Committee focused on developing opportunities for the congregation to come together in fellowship. The committee sponsored a monthly hiking group, hosted the monthly fellowship luncheons and mid-week dinners, had a wonderful booth at the Fall Festival on the Green, which included a Blessing of the Animals, a church and burying ground tours, participated in the Town-wide Halloween Trunk or Treat event, complete with games for the children and organized the hosts for our fellowship hour. We also worked on increasing directed communication to those members whom we had not seen in a while, with the intent to re-engage them in the life of our congregation.

Significant Achievements in 2022:

- In the fall, we moved the mid-week dinners from weekly to monthly, created a theme for each dinner and often had a special activity for the children, which resulted in more participation
- Created new ways to connect with the congregation, especially those who had not been seen since COVID

Ongoing Efforts:

- Set up the hosting schedule for the fellowship hours after the 10 am service
- Interpreted how per capita keeps Presbyterians connected and strong
- Prepared and hosted the monthly Fellowship Luncheons
- Continued to review our church database to keep our membership rolls accurate
- Worked on getting pictures and updated information into the Breeze system
- Participated in the Morristown Trunk or Treat

FINANCE COMMITTEE

Mission Statement:

The Finance Committee oversees and analyzes all financial, budget and investment matters relating to PCM, including monitoring the overall financial needs and health of the church. The Finance Committee provides oversight and guidance to the other Session committees, often through the Treasurer, on committee fundraising efforts, budgeting expenses, and the preparation of annual committee and PCM budgets. Final disposition of all financial matters rests with the Session, except as may be delegated to the Finance Committee either in the Session-approved Finance Committee Manual or on a case-by-case basis.

Summary and Overview:

2023 was a challenging year for the church in several respects. Pledges were under budget, yet member unpledged contributions were over budget by a similar amount. Disbursements were slightly under budget resulting in a slightly positive year-end position. That said, it must be remembered that our total member contributions are far short of our staff-related costs, not to mention building maintenance and program costs. That shortage is made up of endowment withdrawals, the amount of which is not sustainable for the long-term and has not been for several years.

Investment returns for the PCM Endowment Fund were marginal for most of 2023, however, the months of November and December were strong and resulted in a positive total endowment investment return of 10.1%.

In conclusion, the bottom line is simply this: revenues need to increase, and disbursements need to decrease in order for PCM to remain a fiscally healthy and viable church.

Achievements in 2023:

- The Chapel repurposing project was approved by the Finance Committee and Session and financing was arranged using both a \$10,000.00 anonymous donation and funds from the Commemorative Fund.
- Final settlement of the Moyer bequest was received.
- Financial arrangements for the Church on the Green Roof Repair Project, incorporating both a loan and direct payments from the Endowment Fund, were approved by the Finance Committee, Session, Presbytery, the Presbyterian Investment and Loan Program (PILP) and the New Covenant Trust.
- The Annual Stewardship Campaign was conducted, Chaired by Janet Foster.

- In response to a dramatic increase in our premium we changed Property & Casualty insurance carriers and achieved a more reasonable rate.
- We initiated a transition from our old financial software (Parish Soft) to QuickBooks financial software for non-profits to achieve broader accounting transparency and greater processing efficiencies.
- We implemented the Center Credit Card Management System software to achieve more effective oversight and time saving efficiencies for both users and approvers and increased the immediate approval limit requirement to \$250.00 creating even greater efficiencies.
- We initiated greater communication with church members that use the Breeze system to pay their pledges and make other donations in an attempt to encourage individuals to assume the cost of fees incurred in using the Breeze system for donations, rather than pass those costs on to PCM.
- Through consistent negotiation we convinced both Chase and Peapack Gladstone Banks to reduce and eliminate bank fees associated with PCM checking accounts. Thank you, Karen.
- The Annual Church Audit procedure was changed (and implemented) from being performed by a professional CPA firm to a team of five church member auditors at a cost savings of \$10,000.00 a year.
- The Mutch Society (PCM's deferred giving program) has undergone a much-needed revitalization by developing a new and improved brochure along with plans for a 2024 launch to continue this most important source of funding. Such bequests have provided a substantial portion of our Endowment Fund, which in turn helps fund both the ongoing work of the church as well as capital improvements to our aging facilities. Thank you, Bruce Smith and Amanda Tufts.
- The Philips/Dougherty bequest was finalized.

Ongoing Efforts:

- While our transition to QuickBooks was effective January 1st, it is anticipated adjustments to the chart of accounts, various reports, etc. will be required throughout the first quarter of 2024.
- The revitalized Mutch Society will be launched in early 2024 with more frequent and consistent communication and personal engagement with church members.
- Reaching out to PCM members that have become inactive or moved away, to get them engaged or re-connected is critical to our future and not just for financial purposes.
- Renewing the congregations understanding of the purpose and benefits of the PCUSA per capita charge needs to be better communicated.

Acknowledgements:

Each member of the Committee brings his or her own gifts and talents to bear for the benefit of PCM, and I am most grateful for that. To Bruce Fisher for overseeing the Endowment investment portfolio and generating our monthly Investment Reports, Walt for being our legal adviser and overseeing our insurance needs, Betty for chairing the Scholarship sub-committee

and managing the offering deposit assignments, Greg for his investment experience and sound financial perspective, Bruce Smith for the energy and enthusiasm he displays in recognizing and enhancing the importance the Mutch Society plays in the financial health of PCM and for his general business acumen. And last but certainly not least, for the professionalism Karen brings to the budgeting process, maintaining relations with our banks, guiding us toward improved accounting efficiencies with QuickBooks and Center Credit Card Management Software and for overseeing the auditing process. And for Daniel, Paul and Henry, for their insight, their willing support and encouragement, and Janet Foster for her leadership in the 2024 Stewardship Campaign. And for Laura Geary and Beth Baldanzi, faithfully counting and posting the Sunday Worship and Breeze donations. And for the members of the Commemorative, Scholarship and Stewardship sub-committees, we are truly grateful.

Mission Statement: The Outreach Committee provides community service in support of those in need. We offer that support through volunteer action for people of all ages and abilities and direct financial support to organizations that share our commitment. The Outreach Committee promotes building personal and institutional connections between our church, its members, and local and international groups. We strive for diversity and inclusion as we treat all people with respect and understanding, carrying out the directive of Jesus Christ to "love one another."

Introduction:

As we reflect on 2023, we saw inflation at a high, prices for food continue to surge, conflict in Israel and Palestine begin to unfold, and communities in crises in our cities and globally. The Outreach Committee is thankful to God, to our congregation and to our church supported organizations for the many ways given to help support those in need. In 2023, Outreach partnered with organizations that were consistent with our goal of helping neighbors in need with shelter, food, and poverty. Outreach contributed funding to a number of diverse organizations that worked to help the homeless, offer supportive housing, lessen hunger, help refugees, assist with economically challenged families, help individuals of domestic abuse, assist with children's welfare, and assist with humanitarian aid. Throughout the year, Outreach provided "hands on" opportunities to encourage members of all ages to participate in community service work such as serving meals at Table of Hope, working at food pantries, filling backpacks with school supplies, filling nourish.NJ Breakfast Bags with food and assisting with holiday gift programs. Outreach also partnered with our organizations to meet community needs and ran donation drives to stock local food pantries and provide clothing and basic

necessities to those in need. Outreach initiated several fundraisers to support the people and communities affected by earthquakes in Turkey/Syria, by wildfires in Maui, and by conflict in Israel/Palestine and funneled the money raised through Presbyterian Disaster Assistance, which was able to quickly provide on-the-ground assistance. In addition, Outreach provided educational opportunities for members and the public by participating in Diversity Celebration, coordinating World Communion Sunday and working with Table of Hope to host doctors and speakers for Juneteenth in the PCM chapel. Lastly, Outreach formed a team of PCM members to help a refugee family transition to the US from Afghanistan. We are deeply appreciative to PCM and its members who have made our Outreach programs possible. We couldn't do it without you! Our financial and ministry opportunities we supported in 2023 are following:

Significant Achievements in 2023:

- On Monday, January 16, the Outreach Committee formed a team of PCM members to **partner with Refugee Assistance Morris Partners (RAMP) to help an Afghan family** new to our area adapt to life in New Jersey. After a harrowing year in refugee settlement areas in both Dubai and Elizabeth, NJ, the family moved to an apartment in Boonton to integrate into American life. Our volunteer team drives the family to the grocery store, offers transportation for errands, assistance with medical appointments, and tutoring for English and help with short one-off assignments. Good news! We will continue supporting the family as they complete transition to their new life in 2024.
- PCM supported the Morris County **Juneteenth Freedom Day celebration** on Saturday, June 17. Juneteenth was created for all families to celebrate the resilience, solidarity, history, and culture of the Black community. The day included music, local artists, food, and resource tables on the Morristown Green. The Outreach Committee worked with Table of Hope to bring the public to the PCM Chapel to hear from two local speakers about the history of Juneteenth and to interact with a panel of doctors from Atlantic Health. We look forward to helping with the event in 2024.

• The Outreach Committee partnered with Table of Hope in their annual **Backpack Drive** on August 13 to provide Morris County students in need with basic school supplies needed for academic success. Through PCM member's donation of supplies and volunteer's efforts to pack the backpacks, 100 elementary and middle school students were sent off to school with a great start!

- The Outreach Committee initiated three fundraising drives below to support individuals affected by catastrophic events and war:
 - A 7.8 magnitude earthquake near the Turkey/Syria border struck on February 6, affecting 23 million people. The congregation generously donated \$7,496 to a Turkey/Syria Relief Drive to meet needs such as hygiene kits, shelter, medicine, food packages, and psychosocial support.
 - On August 9, multiple wildfires burned on the island of Maui. Thanks to the generosity of the congregation, \$300 was donated to the Maui Relief Drive, along with a donation of \$2,500 from the Outreach Committee to assist with food, shelter, water, sanitation, hygiene, and medicine.
 - Violence escalated in and around Israel/Palestine in early October. Outreach donated \$1,500 funds to the Israel/Palestine Relief Drive and the congregation donated \$857 funds to provide humanitarian assistance including medical supplies, shelter, food, water, and hygiene products.

Ongoing Efforts:

- Outreach continued to support Cohome, a Morristown organization that operates an inclusive home for people with disabilities and their peers to live together as housemates. Cohome director Nate Diskint received the Innovative Housing Award for 2023 from the Supportive Housing Association of NJ. Throughout the year, Outreach members collaborated in various ways with Cohome residents such as making and sharing a meal together, presenting a cello/piano concert by the Kallers, and attending a Friendsgiving event. Residents visited PCM once a month to pack 50 Breakfast Bags for nourish.NJ and represented Cohome at the annual Diversity Celebration on the Morristown Green. As Cohome faced some legal challenges in Morristown, PCM supported them for their existence and the location of their home.
- Outreach committed to **pack 50 Breakfast Bags for nourish.NJ** once each month. Nourish.NJ has opened its wonderful new facility in Dover, NJ where new volunteer opportunities will be available in 2024 for various adults and children's groups in PCM.
- Morris Area Together continues to advocate for those in need of housing and criminal justice. There is also a push to improve ModivCare, the non-emergency transportation for Medicaid patients. There has been changes of staff at MAT in 2023. PCM member Vern Verhoef is now on the board of MAT.
- Due to the distances involved, it is challenging to maintain the **sister church partnership with Eastleigh Presbyterian Church of East Africa**. An Outreach member attended a Presbytery meeting in November concerning partnerships. In December, the PCM partnership team met with Presbytery leaders to discuss where to go from here. In, 2024, the team will attempt to keep the partnership with Eastleigh going forward.
- Interfaith Food Pantry Network (IFPN) Spring and Fall Food Drives: Outreach ran Food Drives for IFPN in May and in October. Each drive has brought in many pounds of food and monetary donations to help those in need of food. The spring food drive collected 723 lbs. of food and \$1,366 in member donations. The fall food drive collected 1,100 lbs. of food for Thanksgiving dinners and \$3,007 in member donations. In addition, members drop off food regularly at the Parish House for IFPN. In 2023, IFPN expanded

their facility by 720 square feet. The expansion offers an incredible "Client Choice Market Place" where clients can walk-in and choose fresh meat, produce, dairy, and frozen foods. The Market Place is open six days per week and several evenings.

- Outreach offered PCM members the opportunity to volunteer to serve over 100 **Table** of Hope meals to-go to those in need one Tuesday per month. PCM members have the chance to work together while making a difference.
- Outreach offers PCM members the opportunity to volunteer at the **Table of Hope** outdoor food pantry one Thursday per month. PCM members help serve 500 people in need of food while getting to know other community volunteers.
- JBWS (formerly Jersey Battered Women's Services) Donation Drive Outreach ran a donation drive with the Vacation Bible School in June to help victims of domestic abuse. Cases of food, diapers, and toiletry items were collected for families, individuals and children at JBWS.
- **Table of Hope (TOH) Fall Coat Giveaway** In October, Outreach partnered with TOH for their annual Coat Drive and collected 103 new and gently used coats to help those in need of warmth.

• **Diversity Coalition of Morris County (DCMC)** - On July 9, the DCMC held Diversity Celebration on the Morristown Green featuring an interfaith service, music, and food led by local organizations. Outreach set up a display table featuring PCM information

and children's activities for visitors of the event. Several Cohome residents were also featured at the table.

- The Outreach Committee **celebrated World Communion Sunday** on October 1 with the congregation by serving breads from around the world, one of the most basic of foods, and its variety, representing differences and similarities around the world.
- **Operation Love** For 39 years, PCM and the Church of God in Christ (COGIC) have partnered to help Morris County families and seniors celebrate Christmas with food and gifts. This year the congregation donated \$4,369 in gift cards in addition to our annual Outreach donation of monetary support for Operation Love. PCM and COGIC members also volunteered to wrap and deliver gift bags to over 450 recipients. We are proud to be a part of this very important ministry for many years.

- Chaplaincy of Morris County Correctional Facility (MCCF) Christmas Gift Program Outreach participated in the Chaplaincy of MCCF Christmas Gift Program and helped offer comfort to inmates by running a donation drive to collect underwear and toiletries for Christmas gift bags. PCM Circle and youth groups also donated home baked cookies to the staff and inmates (an inmate favorite!).
- One Great Hour of Sharing (OGHS) Outreach ran the annual OGHS fundraiser during the season of Lent. Donations support efforts to relive hunger through the Presbyterian Hunger Program, promote development through the Presbyterian Committee on the Self-Development of People and assist in areas of disaster through Presbyterian Disaster Assistance. OGHS collected \$6,010.
- **Christmas Joy** The Christmas Joy offering distributes gifts equally to the Assistance Program of the Board of Pensions and to Presbyterian-related schools and colleges equipping communities of color. Christmas Joy collected \$3,117.
- **Disaster Assistance**: Outreach provided funding to three Presbyterian Disaster Assistance PC USA disaster relief efforts in 2023:
 - Disaster Relief for those affected by Spring Tornadoes with the most impacts in Mississippi, Alabama, and Tennessee – Outreach donated \$2,000 to aid people without water and power from the Spring Tornadoes in March.
 - Disaster Relief for those affected by US Wildfires in Maui Outreach donated \$2,500 to address emergency needs of individuals in August.
 - Disaster Relief for those affected by Israel/Palestine Conflict Outreach donated \$1,500 to deliver aid to those impacted by violence in October.

Mission Statement:

The Mission of the Worship and Music Committee is to ensure that all worship services praise and glorify God, share the work, equip the body of Christ, and nurture our character and faith.

Introduction:

The Worship and Music Committee provides leadership with the ministerial staff in creating meaningful worship experiences, operates Communion and Baptismal Sacraments, oversees the artistic and design aspect of our worship spaces, works in tandem with the Communications Committee to offer worship experiences on a digital platform, and works with the Community and Membership committee to support the Welcome Team. There were two major staff transitions that occurred this year: Ignacio Angulo-Pizarro transitioned to Assistant Director of Music whose responsibilities constitute of Director of ROGs and assisting the Director of Music in leading all other musical ensembles and; Matthew Webb gave notice of his intent to resign from his position of Director of Music as of January 7th, 2024.

2023 Accomplishments & Ongoing Efforts

- Our Music Ministry continues to provide a choral and handbell program for people aged 5 through adults.
- Chancel Choir grew in size this year, with an uptick in basses and altos, respectively.
- The Voices for Life Program was implemented for grades 3-5 as students were paired with an adult musical mentor as they learned more about music and how to use their voices with more individualized focus on the student.
- The Ringers on the Green High School handbell ensemble toured/performed in different locations in England, the first international tour in years.

Mission Statement:

The Y/YA Committee's responsibility is captured in this phrase: "Where Faith Begins and Grace Abounds."

Introduction:

Our church's student ministry believes that our faith in God, Jesus, and the Holy Spirit is always "beginning" in the sense that as a community of believers, our faith is never completed or finished. Faith is something that is constantly changing and growing. We seek to respond to the free gift of grace humbly and gratefully. These represent the heart of our youth ministry. Being a welcoming community that is service-oriented and focused on cultivating faith is what we try to build all of our programming around.

2023 Accomplishments:

- The continuation of a change made in 2022 that moved all student ministry programs to Sunday and re-branding as "Sunday Funday," has made the student ministry a more cohesive experience that has led to increased participation from both the high school and middle school youth groups.

- Senior Recognition Sunday took place on June 11, 2023, when we celebrated four students' completion of high school.
- Members of the youth groups served on occasion as acolytes at the 10AM worship service.

Ongoing Efforts:

- The RISE high school mission trip continued to be one of the cornerstone events of our youth ministry. Thirteen of our students spent a week in upstate New York helping to make homes warmer, safer, and drier.
- This year's group of confirmands are working hard to achieve all the requirements for the program.
- Under the generous-spirited leadership of Abby Semple and Kevin Johnson, the high school and middle school youth programs continue to meet weekly throughout the year. Abby and Kevin have picked up new leadership responsibilities after years of assisting Patrick Allred, who, in December, ended his time as Youth Minister to complete graduate study in Social Work.
- The Youth and Young Adult committee held a successful chili cook-off fundraiser in 2023, with an excellent turnout from the PCM community. The CCO proved to be both a good generator of funds for RISE and a fun opportunity for church members, and families and friends, to enjoy a Friday evening together three years after the initial appearance of the Covid-19 crisis.
- Our student ministry remains focused on local mission projects.

Mission Statement

The Board of Deacons is responsible for the ministry of congregational care and is called to nurture the church family in love and faith as guided by the scriptures.

Introduction

The ministry of Deacons as set forth in Scripture is one of compassion, witness and service, sharing in the redeeming love of Jesus Christ.

The primary responsibility of each Deacon is to care for one or more members of the congregation as assigned by Staff leadership. Deacons strive to make personal contact with their "Concerns" at least once a month and to keep them as closely connected with the church as possible.

Significant Achievements in 2023

- The Deacons began the year with in-person meetings as the Covid threat had lessened. Audrey provided training on the main responsibilities of a deacon in our church.
- The Deacons conducted worship services at Spring Hills Assisted Living Facility on 2/5, 2/19, 4/1, 4/23, 6/4, 6/18, 9/24, 11/5, 11/19, 12/3 and 12/24. Starting in June we served communion at every service by using the elements blessed at our own 8AM service. We are the only church that offers music and singing. The response from the residents and staff has been very positive! If you would like to be added to our list of Speakers and Musicians, please let us know.
- Deacons, along with other members of the congregation, continue to send cards to residents at Spring Hills for holidays and thinking of you cards.

- Deacons were each assigned 20 to 30 member households, who live in New Jersey or out of state, to act as their Deacon. Letters were sent explaining the role of the Deacon and letting them know they could contact their Deacon for such things as a hospital visit, a prayer concern or joy to share, transportation to church services or finding information about the activities in our church. Many favorable responses were received.
- Easter Flowers were delivered to our Concerns after the service.
- In-Reach Day consisted of 11 volunteers who helped four households with outdoor jobs.
- Fall Seminar, *The Good Funeral*, was given by Rev. Audrey Webber on 11/12. This thoughtful and informative seminar was well attended by the congregation. A video is available on the church website.
- Thanksgiving "gift baskets" of fruit and snacks or plants were assembled individually by the Deacons and delivered to Concerns.
- A Christmas get-together was held at the home of Tom Guthrie.

Ongoing Efforts

In addition to the primary responsibilities discussed in the introduction, Deacons also are responsible for the following *traditional* activities:

- Deliver flowers and a Sunday worship bulletin each week to church members who are hospitalized, in a rehabilitation facility or confined to their homes. We have also delivered to people who have difficulty attending services or have had a death in the family to let them know we are still thinking of them.
- Maintain the Deacons' closet which has wheelchairs, walkers, crutches, etc. which can be borrowed for a Concern or anyone in need of the items.
- Distribute *The Upper Room*, a bi-monthly devotional booklet, to our Concerns. This effort will start again in 2024.
- Coordinate and assist with the worship services at Spring Hills Assisted Living.
- Serve communion each month along with Elders and assist in the Maundy Thursday worship service.
- Take minutes and offer devotions and prayers at monthly meetings.
- Distribute Easter flowers to Concerns and others in the congregation who wish to receive them.
- Coordinate and participate in the annual In-Reach Day.
- Host Fellowship Hour. This year we hosted on 6/18 and 10/29.
- Assemble Thanksgiving baskets or plants and deliver to Concerns.
- Remember Concerns on their birthdays with a card.

- Participate in on-going education to better equip ourselves for helping those in need.
- Provide transportation to those needing rides to worship services.
- Present a program of interest to the congregation.

Mission Statement:

Our goal is to provide children with a foundation of skills to use throughout their lives. We offer our students an opportunity for emotional, physical, intellectual, social and spiritual development in a Christian environment. We serve children and families in Morristown and the surrounding community by establishing a nurturing and stimulating atmosphere for young children.

Introduction:

This committee is responsible for overseeing the operation of the Presbyterian Church Nursery School. We report to the Christian Education Committee.

Significant Achievements in 2023:

- We established a summer camp for four weeks, two weeks in July and two weeks in August. Attendance was strong and program was very successful.
- We added a program to extend our hours of care. Three days a week we offered Stay and Play. This is a 2 hour program for children ages 3 to 5 years of age to stay after school. The program is still establishing itself and is gaining traction as the school year progresses.
- Staff hired for 2023/24 school year included: Kristen Singagliese, Robin Fitzgerald, Louise Russ, Jennifer Oberding, Amy Mehl and Karen Healy. Substitute teaching staff – Lori Ann Giardina, Nicole Marucci and Carey Pollacchi.
- Jeanne Mueller is our director.
- Registration for September continues to be lighter than usual.
- The school welcomed three scholarship students in 2023/24 school year. Preschool Advantage supports these students.
- Our "Brightwheel App" continues to allow the school to have better and easier communication with parents and has improved the billing process.
- Social events for parents returned this year with an evening of "Paint and Sip", we participated in the church's movie night and held a cookie decorating class. Feedback has been positive from all that attended. We continue to strive to grow a strong community bond and a bond with our church families and youth programs.

- The school's cleaning company has changed its name, but the staffing is the same: Isabella Cleaners. We have added additional services to include the ladies' room on the first floor of the building three days a week. This was a necessary and helpful addition.
- After-school enrichments this year are: Wee Little Arts, Miss Carol's Sports and Games class, and Stay and Play.
- In School enrichments continue: Yoga, Music, Bible Story with Mrs. Mead and Gym class with Miss Carol are offered to the school community during the school day.
- Music continues to be in flux the music teacher, Patrick Allred, was unable to continue classes. We are using a variety of teachers this year and hope to find one that works best with our schedule and students. Musically Mindful was here in December for the children and provided a staff workshop as well.
- JAM, the church music program started by Julie Ramseyer is still not running.
- Weekly emails are sent to parents by the director through Mail Chimp.
- Parent Education Events were provided with Happynestmd.com. Dr. Beth Gelman presented on Taming the Tantrum and Raising Healthy Eaters.
- Morris Speech Therapy provided screenings for students to identify students who may have speech delays. This was open to any families that chose to participate.
- 2024 is a Relicensing Year. The school will begin its relicensing requirements starting in September 2024 and submit by December 2024 as the license expires in March of 2025.

Ongoing Efforts:

- The school website at www.pcnsmorristown.org continues to be a source for information for new families interested in our school as well as information for current families.
- Our social media imprint has increased with more Instagram posts, reels, stories and followers. This raises our online profile and increases awareness of our program to reach new families.
- We maintain connections with local schools like Peck School and Red Oaks School to help us connect with other families looking for preschools.
- A celebration of 60 years of Presbyterian Church Nursery School in Morristown will take place on May 23, 2024.

To the Members and Friends of The Presbyterian Church in Morristown:

2023 Annual Report of the Treasurer

The pages of this report will detail the Church's financial activities in 2023. A narrative summary is shown below.

Operating Results:

Our Operating Results were favorable for both revenue and expenses compared to the 2023 budget.

Revenue was \$41,000 over budget:

- Pledges fell short of our \$800,000 pledge goal. Our pledge receipts were \$761,411 which is about \$39,000 lower than budget.
- However, Member Unpledged donations, Non-Member Donations and Plate were above budget which offset the pledge shortfall.
- B&G Parking and Building Use revenue was over budget, but Per Capita donations fell short. Other Committee revenue was close to budget.

Expenses were \$32,000 under budget (favorable):

- B&G spent less on Supplies and Maint than budgeted
- M&A was favorable due to Youth Director going Part-Time during the year.
- Finance was over budget due to Insurance Premiums for 2024 being prepaid in Dec 2023

Note that the Church's Operating budget is compiled at a loss and makes up the shortfall with an annual withdrawal from the Endowment. See below for more details.

Major Maintenance:

• In 2023, the church continued to invest in and maintain our 5 buildings. The total cost of expenditures for Major Maintenance in 2023 was \$64,299. Projects include Electrical Work and Pavers at the Manse. About \$34,000 is being held for 2024 MM projects.

Endowment:

Our budgeted withdrawal from the endowment for 2023 for the **Operating Budget, Major Maintenance and Special Funds** was \$694,758. Actual withdrawal for these categories totaled only \$653,757. We received bequests of \$724,552. Please see the Endowment schedules for further information.

2024 Budget

The 2024 Budget is the last page of this packet. Our pledge budget is lower for 2024 at \$775,000 reflecting the lower trend of the past few years (side note: there's still time to pledge!) Expenses are expected to be lower in 2024 due to some open staff positions.
